GR/2022/134/LBL/192020/510460/M3, dated the 14<sup>th</sup> October, 2022, inviting objections and suggestions from all persons likely to be affected thereby within a period of thirty days from the date of publication of the said notification in the *Official Gazette*;

**AND WHEREAS** no objection or suggestion has been received by the Government in respect of the said draft notification;

NOW THEREFORE in exercise of the powers conferred by section 35 of the Inter-State Migrant Workmen (Regulation of Employment and Condition of Service) Act, 1979 (30 of 1979), the Government of Gujarat hereby makes the following rules further to amend the Inter-State Migrant Workmen (Regulation of Employment and Condition of Service) (Gujarat) Rules, 1981, namely: -

- 1. (1) These rules may be called the Inter-State Migrant Workmen (Regulation of Employment and Condition of Service) (Gujarat) (Amendment\*) Rules, 2023.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Inter-State Migrant Workmen (Regulation of Employment and Condition of Service) (Gujarat) Rules, 1981 (Hereinafter referred to as "the said rules"), -
  - I. In rule 4 after sub-rule (1) the following rule shall be inserted namely: "(A): The Registering Authority shall grant the registration within 45 days
    after receiving the application if satisfied about the eligibility of the
    applicant. In case of failure to issue registration within stipulated time
    shall be deemed approval"

II. In rule 9 after sub-rule (1) the following rule shall be inserted namely: "(A): The Licensing Authority shall grant the license within 45 days after
receiving the application if satisfied about the eligibility of the applicant.
In case of failure to issue license within stipulated time shall be deemed
approval"

- 2. In the Contract Labour (Regulation and Abolition) (Gujarat) Rules, 1972,
- I. In rule 18, after sub-rule (1) the following rule shall be inserted namely: "(A): The Registering officer shall grant the registration within 45 days after receiving the application if satisfied about the eligibility of the applicant. In case of failure to issue registration within stipulated time shall be deemed approval."

II. In rule 23, after sub-rule (1) the following rule shall be inserted namely: "(A): The Licensing officer shall grant the license within 45 days after receiving the application if satisfied about the eligibility of the applicant. In case of failure to issue license within stipulated time shall be deemed approval"
